**Warm ups:** Warm up lanes will be determined after entries are received. Lane Assignments will be given in the coaches' packets, which will be available at the admissions table and e-mailed prior to the meet. Session 2 warm up times will be announced following Session 1.

**Rules:** USA Swimming technical rules will be followed, as well as all ISI rules that apply.

**Timed Finals:** All events will be conducted on a time final basis.

**Entry Limitations:** Swimmers may enter up to three individual events and four total events. This meet will be limited to 500 total swimmers or the complete entry of the last team entered as the time line permits for a particular session. Please **no** "no time" entries.
