**Entries**

Swimmers may enter up to **4 events** Saturday and Sunday.

Entry times should be in SCY. Teams must submit their entries in a Hy-Tek file, zipped in an e-mail.

A printed report including full name, USA swimming number, event numbers, and entry times of all Swimmers must be included with the entry. This report will serve as your official entry form. Relay entries and, a signed release with fee summary must accompany the entry.

All ISI and USA Swimming safety rules will be enforced.

**USA Swimming  
Membership**

Insurance regulations require that all Swimmers, Coaches, Judges, Starters, and Referees be current members of USA Swimming, Inc. It is each Club’s responsibility to register their Swimmers, Coaches and, Officials. Swimmers, Coaches and Officials who are not current members of USA Swimming, Inc. may not participate in the meet or be on the pool deck.

Coaches and Officials must display their credentials at all times.

**Swimmers  
With  
Disabilities**

In accordance with USA Swimming Rules, Articles 105 and 202.1.13, the Meet Referee has the authority to accommodate Swimmers with disabilities. It is the responsibility to the Coaches

Or Swimmers to contact the Meet Referee with specific requests.

**Awards**

Ribbons will be awarded for 1<sup>st</sup>-8<sup>th</sup> place in each individual event.  
**Swimmers in the 13 & Over groups will not Receive ribbons.**  
High Point trophies will be awarded to the Top 3 Swimmers in age groups under 13 years old.

**Scoring**

9-7-6-5-4-3-2-1 for individual events.

**Seeding**

All events will be swum slowest to fastest, except the 1650 Freestyle  
This will be swum fastest to slowest, alternating women, and men.

**Starts**

At the Meet Referee's discretion, fly-over starts may be implemented  
In order to ensure that each session is completed in a timely manner.

**Limits**

The Host Team reserves the right to limit the number of heats swum for  
All events, in order to ensure the completion of the session within a 4 hour  
time frame. Any entries cut by the Host Team will not be refunded. The  
Host Team also reserves the right to swim a heat of its own Swimmers  
after the cut has been made.

**Concessions**

Food and beverages will be available. Food may be eaten in the  
concession area. **NO FOOD OR DRINK WILL BE ALLOWED IN THE  
POOL STANDS OR ON THE POOL DECK.** No smoking is allowed  
Anywhere on Lockport Township High School property by State law.

# CONTROLLED MEET WARM-UP and SAFETY GUIDELINES

To be posted at all ISI Sanction/Approved competitions

## A. WARM-UP PROCEDURES

1. **General Warm-up** (first 30-45 minutes)
  - a. **NO DIVING** allowed from the blocks or edge of pool. Swimmers must enter the pool feet first, while maintaining contact with the deck with the body and a hand from the start end of the pool.
  - b. No sprinting or pace work allowed during this general warm-up session.
  - c. Entry into pool from starting end of pool only, unless noted otherwise by the meet director and meet referee.
2. **Specific Warm-up** (last 30-45 minutes)
  - a. **Push/Pace Lanes** - Push off one or two lengths from starting end. Circle swim only. **NO DIVING.**
  - b. **Diving Lanes** - Sprint lanes for diving from blocks or for backstroke starts in specified lanes at designated times. (One length only)
  - c. **General Warm-up Lanes - NO DIVING.** Circle swim only.
  - d. At approximately half way through diving and push/pace, additional lanes may be opened at the request of the coach.

## B. SAFETY GUIDELINES

1. **Coaches Responsibilities**
  - a. Coaches shall instruct their swimmers regarding safety guidelines and warm-up procedures as they apply to conduct at meets and practices.
  - b. Coaches shall actively supervise their swimmers throughout the warm-up session at meets and all practices.
2. **Host Team Responsibilities**
  - a. Marshaling
    - 1) A minimum of two (2) marshals, who report to and receive instructions from the Meet Referee, shall be on the deck during the warm-up session.
    - 2) Marshals shall be current members of USA Swimming.
    - 3) Marshals shall have the authority to remove from the deck, for the remainder of the warm-up session, any swimmer or coach who is in violation of safety or warm-up procedures.
  - b. The host team shall provide signs for each lane at both ends of the pool, which indicate the designated use during warm-up.
  - c. Warm-up times and lane assignments shall be published in the meet information and posted at several locations around the pool area. The following statement shall appear in the information: "Illinois Swimming, Inc. Safety Guidelines and Warm-up Procedures will be in affect at this meet."
  - d. An announcer shall be on duty for the entire Warm-up session to announce lane and/or time changes and to assist with the conduct of the Warm-up.
  - e. Hazards in locker rooms, on the deck area or in areas used by coaches, swimmers, spectators, or officials shall be removed or clearly marked.
3. **Miscellaneous:**
  - a. Backstrokes shall ensure that they are not starting at the same time as a swimmer on the blocks.
  - b. Swimmers shall not jump or dive into the pool to stop another swimmer on a recalled start.
  - c. Swimmers are required to exit the pool upon completion of their warm-up to allow other swimmers adequate warm-up time. The pool is not for visiting or playing during the warm-up session.
  - d. Warm-up procedures shall be enforced for any breaks scheduled during the competition.
  - e. The Referee may restrict use of bands, hand paddles, or fins during warm-up. The Referee shall have control over mitigation actions necessary to relieve situations deemed as dangerous or impairing the safety of other swimmers.

**NOTE:** Host clubs may, with the consent of the Meet Director and Meet Referee, modify the warm-up time schedule or recommended lane assignments depending on pool configuration, number of swimmers or other consideration, so long as safety considerations are not compromised. Any such changes shall be announced, and/or posted prominently in the pool area.
