**1650 Free** Saturday/Sunday evening. Begins 15 minutes after conclusion of regular session. Swimmers must provide their own timers (two) and their own lap counter.

**LOCATION:** **Metea Valley High School**  
**1801 N. Eola Road**  
**Aurora, IL 60502.**

**FACILITY:** The pool is a twenty five yard, eight-lane pool with non-turbulent lane lines. The pool is thirteen feet deep at the start going down to eight feet at the turn end. There is also a three lane warm-up or cool-down pool which varies in depth from three feet to four feet four inches. An electronic Colorado Timing System will be used with touch pads and a readout board. The athletic hallway will serve as the team area and concessions will be sold in this area as well. Additionally, drinks and packaged goods will be sold in the pool balcony concession stand and only the goods purchased at the pool concession stand may be eaten while sitting in the pool balcony. The school grounds are smoke free, and patrons should enter through Door 25 which is the Aquatics Entrance.

**RULES & SAFETY:** All USA and ISI swimming rules and ISI safety rules will be strictly enforced.

**ELIGIBILITY:** All USA Swimming registered swimmers are eligible. All swimmers must be registered prior to entry deadline. Entries listed as "Registration applied for" will not be accepted. Registration forms can be obtained from the Illinois Swimming Office, 1400 E. Touhy Ave, Suite 245, DesPlaines, Illinois, 60018 Phone 847-824-1596 Fax 847-824-1726. A swimmer's age as of January 6, 2012 will determine their age for the meet. Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the

water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement."

**USA SWIMMING MEMBERSHIP:** Insurance regulations require that all swimmers, coaches, judges, starters, and referees be a current member of USA Swimming. It is each club's responsibility to register their swimmers, coaches, and officials. Swimmers, coaches and officials who are not current members of USA Swimming may not participate in the meet or be on deck.

**COACHES:** All coaches must be currently registered with USA Swimming and must continuously display their current USA Coach Member registration card at all times while on deck.

#### **ENTRY**

**DEADLINE:** Entries will not be accepted by the Entry Chairperson before 9:00 a.m. Monday, December 5, 2011.

Hand deliveries and faxed entries will not be accepted.

Entries will be accepted on a first-received-first-entered basis until the maximum time limit, subject to the 4 hour/10 hour rule is reached. Entries received thereafter will be returned immediately. Please provide the contact information of your club representative so they may be contacted.

#### **ENTRY**

**LIMITATIONS:** **ABSOLUTELY NO DECK ENTRIES WILL BE PERMITTED.**

Swimmers may swim a **maximum of 3 individual events plus one relay per session** except for Friday evening. **On Friday evening, swimmers 12 & under are limited to 1 event.**

#### **ADDITIONAL LIMITATIONS:**

The following events may be limited to the 4 fastest heats based on times submitted for entry:

The host team reserves the right to limit the number of heats to conform to a four-hour time limit for each session.

A 1650 free will be offered. The top 24 qualifying times for girls and top 24 qualifying times for boys will swim (fastest to slowest).

Should limitations be necessary, a copy of those sessions, including the 1650 session, will be sent to each team so that affected swimmers may be notified.

Any swimmer entered in more than the maximum events on the meet entry will be scratched from the last events entered (when the entry is input into the computer) until the maximum of 4 events on Saturday and Sunday and 1 event on Friday for 12 & Under age group swimmers or 2 events on Friday for 13 & Over age group swimmers is reached. Relay swimmers must be entered in at least one individual event.

**ENTRIES:** All entries will comply with current USA Swimming and ISI Rules and Regulations. Current registration number, age, first name, middle initial, and last name must appear on all entry blanks. Computer entries can be made using the latest version of Hy-tek Meet Manager on a 3.5 inch data disk. All entries must be accompanied by a hard copy printout of your entry data file.

A completed and signed Summary Fee/Release Form and entry check for payment in full must be received within five business days of receipt of the e-mail. Checks are to be made payable to the Maverick Swim Club. Failure to enclose all required paperwork shall be sufficient grounds for refusal of the entry.

Meet host will accept no responsibility for transmission errors of entries. It will remain up to the sender to verify

receipt of entries.

ENTRIES WILL BE ACCEPTED ONLY AT THE ABOVE ADDRESS FOR THE MEET ENTRY CHAIRPERSON.

**ENTRY FEES:** The entry fee for individual events is \$3.00 per event. The entry fee for relays is \$7.00 per relay. A surcharge of \$2.00 per swimmer has been instituted by ISI.

**ENTRY VERIFICATION:** If you desire verification of entries received, include a stamped self-addressed postal card with your entries.

**SEEDING:** The conforming time standard for this meet is short course yards. Swimmers will be seeded and swim from slowest to fastest. All non-conforming times will be seeded last in rank order.

**RELAY EVENTS** Preprinted relay cards will be available in the coaches packet. Coaches are to list the relay swimmers' last names and first initials on the card. All cards must be returned to the scorers table.

**STARTING:** FINA starting procedures and rules (whistle commands and no recall) will be in effect for this meet. In accordance with USA Swimming Rules; Articles 105 and 202.1.13, the Meet Referee has the authority to accommodate swimmers with disabilities. It is the responsibility of the coaches and swimmers to contact the Meet Referee, prior to competition, with special requests.

**POSITIVE CHECK- IN:** This meet will utilize positive check-in for all sessions. Positive check-in will close 40 minutes prior to the first event for each session. A separate positive check-in for the 1650 Free will be held beginning at 4:00pm. 1650 positive check-in will close 40 minutes prior to the first heat of that event. Swimmers not checking in will be considered a scratch for that session's events. Late check-ins will be able to swim only if there are open lanes available in the slower heats.

**OFFICIALS & MEET WORKERS:**

Officials are needed. Teams will also need to provide timers for all sessions. **SWIMMERS IN THE 1650 MUST PROVIDE 2 TIMERS AND A LAP COUNTER TO BE ABLE TO SWIM.**

**RESULTS:** Results will be posted as the meet progresses. One copy of printed meet results in required format will be mailed to all teams represented by 5 or more swimmers.

**AWARDS:** Awards will be given as follows:

Final results for the 13/14 year old swimmers and the 15 and over swimmers will be determined separately. 15 and Over swimmers will not receive awards.

A, B, C swimmers will be determined by final results, not seed times.

Teams are requested to designate an individual to pick up their respective awards following completion of the Sunday afternoon session.
