## Course Information and Prerequisites

- Officials who apply to attend the course must be available for the classroom/theory portion of the course on Friday, May 14 and Saturday, May 15, and available to officiate all sessions of the competition on Saturday, May 15 and Sunday, May 16.
- Officials applying for the course must be a Referee, Starter or Judge of Stroke.
- The accreditation course will be limited to 6 officials (for evaluation purposes).
- Officials working the meet (outside of the 6 accepted to the course) who wish to sit through the classroom sessions for educational purposes are welcome to do so, but will not be evaluated for national certification.
- Officials who participate in the course are responsible for their own travel and accommodations during the course and the competition. (Please see meet packet for information on local accommodations.)
