If you don't have your 10 sessions (4 for Administrative Judges) or CEUs (for Referees) done yet, and need additional time, you may request an extension to 2/15/08 by contacting the ISI office (ilswimoffice@sbcglobal.net), but you will still need to renew as a non-athlete member of USA Swimming to be on deck.

Please note: If you haven't renewed your non-athlete membership and are requesting an extension to meet the session/CEU requirement, you will not be allowed on deck due to insurance and liability issues.
