(3) N2/N3 certification processing deadlines for ISI Officials

The N2/N3 certification forms are processed twice a year, at the conclusion of the short course season, and at the conclusion of the long course season. The cutoff from the short course season is now, please make sure any applications you wish to have considered are put in the mail no later than Tuesday, May 8; the cutoff for applications after the long course season is August 30. The \$5 processing is covered by ISI.

(4) Online testing offline until May 15

The USA Swimming online testing is offline until May 15 for updates, revisions, and compliance with the 2007 rulebook. Tests taken beginning May 15 must comply with the 2007 rulebook.
